## **SERVICE OF PROCESS AND COURT FILING RATE SHEET**

**ALL CHARGES ARE PER ADDRESS AND PER DEFENDANT**

### **LEVELS OF SERVICE:**

Routine Service: First attempt in 3-5 days, subsequent attempts 2-3 times a week.

Rush Service: 5 attempts within 7 days, subsequent attempts made every 48 hours

### **ROUTINE SERVICE FEES:**

#### **Contra Costa County: \$78-\$90**

\$78- San Ramon, Danville, Blackhawk, Walnut Creek, Alamo, Diablo, Pleasant Hill, Concord, Clayton, Lafayette, Orinda, Moraga, Bay Point, Pittsburg, Antioch, Martinez, Oakley, El Cerrito, Richmond, San Pablo, El Sobrante, Pinole, Hercules, Rodeo

\$90- Bethel Island, Crockett, Byron, Knightsen, Discovery Bay, Brentwood, Morgan Territory, Back part of Clayton

#### **Alameda County: \$78-\$90**

## **RUSH FEES:**

**Contra Costa County:** \$43 on top of routine service fees

**Alameda County:** \$43 on top of routine service fees (depending on location)

**Please note: Service Requested for Rush after 2-3pm: \$35-\$50 on top of Rush Fees**

**Santa Clara County:** \$95 (Routine); \$146 (Rush)

**San Mateo County:** \$95 (Routine); \$146 (Rush)

**San Francisco County:** \$95 (Routine); \$146 (Rush)

**Solano County:** \$95 (Routine); \$146 (Rush)

**All Other Counties:** Call for a quote

**Outlying Area Charge:** \$5-\$10 (cities with rural areas will call after 1st attempt)

**Wait Time:** First 20 minutes included, \$1 per minute charged for time exceeding 20 minutes.

## **EXTRA (Depending on location)**

**Statewide Service of Process:** Call for a quote

## **COURT FILINGS:**

**Routine:** Will be filed in 3-4 business days

**Rush:** Will be filed same day or next day

**Routine Filings:** (same price as a Rush)

**Contra Costa County:** \$70 (Martinez). \$76 (Pittsburg). \$80 (Richmond)

\$25 for each additional case number; \$25 special handling fee for requests for specific times

**Alameda County:** \$95 Berkeley, Oakland, Alameda; \$111 Hayward

\$25 for each additional case numbers; \$35 special handling fee for requests for specific times

**All Other Counties:** Call for a Quote

### ADDITIONAL SERVICES:

**Restraining Orders:** \$78-\$95

**Special Handling:** \$35-\$50

**Bad Address:** Charge same as service fee

**Field Locate:** \$25 per address

**Additional Attempts in Same Day:** \$25 per attempt

**Email and Fax Charge:** 20 pages or more is \$.15 cents per page.

**Stakeout Hourly Rate:** Contra Costa County \$100/hour, Alameda County \$100/hour. All other

counties call for a quote. 1 hour minimum. Does not include cost of process serving. Stakeouts

after 10 pm: an additional \$10-\$15 per hour.

**Time and Mileage:** \$65/hour (this rate is time and mileage combined). Most likely will use

courier rates here.

**Skip Traces:** \$78 without service of process (\$50 for each person/additional assignment).

\$30 with service of process (\$15 for each person/additional assignment) \$121 – (Same Day)

**Pick up Fees:** \$25 for pick-up of assignments in Walnut Creek. \$50 for pick-up of assignments

in Alamo, Danville, San Ramon, and Pleasanton

\*Call for a quote if out of the above areas

### COURT RESEARCH:

**Contra Costa County:** \$65/per hour for 1<sup>st</sup> hour, \$65/hour after, billed 15-minute

increments (Richmond add \$10/hour)

**Alameda County:** \$70/hour for 1<sup>st</sup> hour, \$65/hour after, billed 15-minute increments

(Fremont add \$10/hour).

**All Other Counties:** \$70/hour for 1<sup>st</sup> hour, \$65/hour after, billed 15-minute increments.

### **RATES FOR WAGE GARNISHMENT AND BANK LEVIES**

\$100 - For Preparation and Filing of Writ with local court

\$150 - (Contra Costa County) For Bank Levies and Wage Garnishments

\$175 - (Alameda County) For Bank Levies and Wage Garnishments

\$175 and up: Out of County (call with area for quote)

### **WAGE GARNISHMENT/BANK LEVY SERVICE INCLUDES:**

-Preparation of documents

-Opening File with Sheriff

-Serving Employer/Bank

-Closing file with the Sheriff with the proof of service within 5 days from the date the

employer/bank is served.

### **ADDITIONAL WAGE GARNISHMENT/BANK LEVY FEES INCLUDE:**

\$25 - To issue Writ of Execution (Make \$25 check payable to the "Clerk of the Court")

\$35 - For Wage garnishments (Make check payable to specified county of Sheriff)

\$40 - For Bank Levies (make check payable to specified county of Sheriff)

**\*All of the above fees are recoverable costs**
